Greetings from the National Service Committee (NSC) of the Catholic Charismatic Renewal!

I am writing to you on behalf of the NSC to invite you or your organization to participate with other individuals and leading organizations in the Catholic Charismatic Renewal in the purchase of The Ark and The Dove, as described more fully herein and on the website www.TheArkAndTheDoveWorldwide.org.

BACKGROUND AND PURPOSE FOR PURCHASE. In February of 1967, at a Retreat Center north of Pittsburgh called The Ark and The Dove, the Holy Spirit fell in power on a handful of Duquesne University students. Many in the Catholic Charismatic Renewal trace our beginnings back to this event.

Recently, the NSC was notified that The Ark and The Dove (currently called Providence Villa) is for sale and that we have the opportunity to compete in the bidding process.

We hope that our purchase of The Ark and The Dove will help unify the various expressions of the Renewal worldwide and rally Charismatics to a greater fulfillment of the commission given by the recent popes, and most recently Pope Francis, to actively carry out the New Evangelization to rebuild the Church using our charismatic gifts.

FUNDRAISING AMOUNT AND TIMETABLE. In this regard, the NSC is coordinating the process to raise \$1.5 million to fund the purchase. This fundraising effort must be substantially completed by October 19th, which is 60 days after the NSC's execution of the agreement to purchase the property. If such fundraising is not substantially complete by then, the NSC may be put into the position of terminating the purchase agreement, which would open the purchase to other interested bidders outside of the Renewal. If the purchase is terminated, donations will be returned. Assuming sufficient fundraising, it is expected that the purchase will be completed by yearend 2015. The NSC has already paid a 5% earnest money deposit, and is covering the initial legal, title, inspection and other costs.

FORMATION OF NEW NONPROFIT FOR PURCHASE. Although the NSC is spearheading the purchase, due diligence and fundraising efforts, the intent is to form a new nonprofit company to acquire The Ark and The Dove, and all funds raised by the NSC for this purpose will be provided to the new nonprofit. The Board of Directors of the new nonprofit will be composed of leaders of various Renewal groups worldwide and other individuals, with a preference given to those making major contributions. The fundraising campaign has several components, but the first and most important is identifying major Renewal partners to participate in this purchase. There will be an ongoing effort to raise funds from individuals extending beyond closing.

HOW YOU CAN HELP. We seek your participation in executing this vision in the following ways:

- Contribute significantly to fund the purchase. We are seeking several major donors, both individuals and groups, to each contribute at least \$100,000. Such donors will be invited to participate on the Board of the new nonprofit. Contributions should be made to the National Service Committee and the funds will be deposited in a special purpose account pending the purchase.
- **Invite others to donate.** We would request that major donors support the fundraising effort by contacting their communities and networks to encourage others to donate.
- Share your ideas. As the Body of Christ, we recognize that we must work together, led by the Holy Spirit with Christ as the Head. Accordingly, we encourage you to share your ideas for fundraising and the future business plan of The Ark and The Dove.
- **Pray.** We humbly ask for your prayers as we seek to execute this vision to rally the Renewal worldwide and build the Kingdom.

The Holy Spirit is doing something new. Clearly Pope Francis has called the Catholic Charismatic Renewal forward to bring the charisms and the baptism of the Holy Spirit to the heart of the Church. With The Ark and The Dove as a rallying point, Renewal groups worldwide can unify efforts to be more effective in carrying out the mission to preach the Gospel to all nations, and to encourage others to experience the love of God, to enter into a personal relationship with Jesus Christ and to use the charismatic gifts to build the Kingdom.

Historical Site of the "Duquesne Weekend"

Introduction. In response to Pope Francis' commission to the Renewal, in the hopes of unifying the many expressions of the Renewal, in anticipation of the Jubilee and the 50th anniversary of the Duquesne Weekend, to reclaim our historical site, to increase the visibility and identity of the Catholic Charismatic Renewal, to proclaim the love of God though His Son Jesus in the POWER of the Holy Spirit, The Ark and The Dove can be that rallying point for the Renewal worldwide!

The Duquesne Weekend. In February 1967, about 25 college students from Duquesne University attended a retreat at The Ark and The Dove Retreat Center near Pittsburgh. It was on this retreat that the Holy Spirit fell in power. Today, we trace the beginnings of the Catholic Charismatic Renewal back to this historic event. Purchase of The Ark and The Dove Retreat Center. In January 2015, the NSC was notified that this retreat center, currently owned by the Sisters of Divine Providence and called Providence Villa, would be for sale. Trusting in God's providence, trusting that we stay in His will, we have begun the process of purchasing the property with expectations of joint ownership with other renewal groups. Our hope is to secure the property and reclaim its identity as The Ark and The Dove.

The Duquesne Weekend

People frequently ask me if I ever get tired of telling the story of the Duquesne Weekend. I never do, because it's a love story – the story of God's gracious and extraordinary response to the prayer of some very ordinary people.

In Luke 11 Jesus says, "Ask and you shall receive, seek and you shall find; knock and it shall be opened to you. If you who are evil know how to give your children good things HOW MUCH MORE will the Heavenly Father GIVE THE HOLY SPIRIT to those who ASK HIM." Here is an unfailing principle: From the first Pentecost on, the Holy Spirit has always come in response to fervent prayer... to prayer that is hungry and thirsty for more of God...to prayer that asks, seeks, and knocks. I describe in my book, As By A New Pentecost, how the entire twentieth century was dedicated to the Holy Spirit in a special way. Blessed Elena Guerra, at the turn of the twentieth century, urged Pope Leo XIII to call the entire Church to pray more fervently to the Holy Spirit...to be, as it were, a permanent Cenacle of prayer. And of course you remember the prayer to the Spirit we prayed for the Second Vatican Council: "Divine Spirit, renew Your wonders in this our day as by a new Pentecost."

In the Spring of 1966, two Duquesne University professors were ASKING, SEEKING, and KNOCKING. They had pledged themselves to pray daily for a greater outpouring of the Holy Spirit in their lives using the beautiful Sequence Hymn of Pentecost. In the midst of this time of prayer, some friends gave them two books: The Cross and the Switchblade and They Speak With Other Tongues. Both books describe the experience of the Baptism in the Holy Spirit. The men from Duquesne realized that this Baptism in the Spirit was precisely what they were searching for.

In January 1967, four Catholics from Duquesne attended their first interdenominational charismatic prayer meeting – the Chapel Hill meeting – in the home of Miss Flo Dodge, a Spirit-filled Presbyterian. Interestingly enough, a few months before these Catholics came, the Lord led Flo to read Isaiah 48 where He announces that He is about to do "a new thing".

Indeed, God was about to do a new thing among Catholics as a result of the prayer meeting. The people from Duquesne were impressed with what they witnessed there. On January 20, two of the men returned. They received the Baptism in the Holy Spirit and began to manifest charismatic gifts. They returned home to pray with the other two who had not attended that night.

At this time I was a member of the Chi Rho Scripture Study group that met on the Duquesne campus. Two of these professors served as moderators of Chi Rho, and although they did not tell us outright about their charismatic experience, those who knew them well noticed that they radiated a new joy. We were planning for our retreat in February and the professors suggested a new theme: "The Holy Spirit." In preparation for the retreat, they told us to pray expectantly, to read The Cross and the Switchblade, and to read the first four chapters of the Acts of the Apostles.

A few days before the retreat, I knelt in my room and prayed, "Lord, I believe I've already received your Spirit in Baptism and Confirmation. But if it's possible for your Spirit to be more at work in my life than He's been up until now, I WANT IT!" The dramatic answer to my prayer was soon to come.

On February 17 about 25 of us left for The Ark and The Dove Retreat house on the outskirts of the city. As we gathered for each session, our professors told us to sing as a prayer the ancient hymn, Veni Creator Spiritus, "Come Creator Spirit". On Friday night there was a meditation on Mary. Then we had a Penance Service. In John's Gospel we read that when the Holy Spirit comes He will convict the world of sin. That's what happened among us as we repented in the Sacrament of Reconciliation.

On Saturday a member of the Chapel Hill Prayer Group came to speak on Acts, chapter 2. All we were told was that she was a Protestant friend of our professors. Although her presentation was very simple, it was filled with spiritual power. She spoke about surrendering to Jesus as Lord and Master. She described the Holy Spirit as a Person who empowered her daily. Here was someone who really seemed to know Jesus intimately and personally! She knew the power of the Holy Spirit like the Apostles did. I knew I wanted what she had and I wrote in my notes, "Jesus, be real for me."

In the discussion following her talk, David Mangan proposed that we close our retreat by renewing our Confirmation...that we, as young adults, say our personal "yes" to the Holy Spirit. I linked my arm through his and said, "Even if no one else wants to do this, I do." Then I tore out a sheet of paper and wrote, "I want a miracle!", and posted it on the bulletin board.

Saturday night a birthday party was planned for a few of our members, but there was a listlessness in the group. I wandered into the upstairs chapel...not to pray but to tell any students there to come down to the party. Yet, when I entered and knelt in the presence of Jesus in the Blessed Sacrament, I literally trembled with a sense of awe before His majesty. I knew in an overwhelming way that He is the King of Kings, the Lord of Lords. I thought, "You had better get out of here quick before something happens to you." But overriding my fear was a much greater desire to surrender myself unconditionally to God.

I prayed, "Father, I give my life to you. Whatever you ask of me, I accept. And if it means suffering, I accept that too. Just teach me to follow Jesus and to love as He loves." In the next moment, I found myself prostrate, flat on my face, and flooded with an experience of the merciful love of God...a love that is totally undeserved, yet lavishly given. Yes, it's true what St. Paul writes, "The love of God has been poured into our hearts by the Holy Spirit." My shoes came off in the process. I was indeed on holy ground. I felt as if I wanted to die and be with God. The prayer of St. Augustine captures my experience: "O Lord, you have made us for yourself and our hearts are restless until they rest in You." As much as I wanted to bask in His presence, I knew that if I, who am no one special, could experience the love of God in this way, that anyone across the face of the earth could do so.

I ran down to tell our chaplain what had happened and he said that David Mangan had been in the chapel before me and had encountered God's presence in the same way. Two girls told me my face was glowing and wanted to know what had happened. I wasn't familiar enough with the Scripture to know that passage in II Corinthians where it describes Moses whose face shone when he returned from the mountain. St. Paul writes: "All of us, with unveiled faces, beholding the beauty of the Lord are being

transformed from one degree of glory to another." I led these two students into the chapel and began to pray, "Lord, whatever you just did for me, do it for them!" That was probably the shortest Life in the Spirit Seminar on record!

Within the next hour God sovereignly drew many of the students into the chapel. Some were laughing, others crying. Some prayed in tongues, others (like me) felt a burning sensation coursing through their hands. One of the professors walked in and exclaimed, "What is the Bishop going to say when he hears that all these kids have been baptized in the Holy Spirit!" Yes, there was a birthday party that night, God had planned it in the Upper Room Chapel. It was the birth of the Catholic Charismatic Renewal!

When we returned to campus, we created quite a stir. One friend told me, "Patti, if I didn't know you better, I would say you were drunk!" Like the Apostles after Pentecost, we couldn't help but speak of the things we had seen and heard. We literally stumbled into charismatic gifts like prophecy, discernment of spirits, and healing. One of our professors witnessed to his friends at Notre Dame and Michigan State University in these words: "I no longer have to believe in Pentecost; I have seen it!" In the past 40 years the grace of this new Pentecost has spread from a handful of students on the Duquesne Weekend to millions of Catholics around the world. Why? Because God is determined to send forth His Spirit to renew the face of the earth!

One final word: In his foreword to my book, As By a New Pentecost, Cardinal Suenens wrote that "Jesus Christ continues to be born mystically of the Holy Spirit and of Mary," and that we should never separate what God has joined together. If we in the Renewal want to proclaim Jesus to the world, we need the Holy Spirit and we need Mary, the Mother. Just as Mary was in the Upper Room at Pentecost, she is with us whenever we return to the Upper Room. If only we would welcome her as Mother as did the beloved disciple John, she will teach us: how to surrender to the Father's will, how to be faithful to Jesus unto the Cross, how to pray with a humble, pure and docile heart for more of the Holy Spirit, how to be one family. She is the Spouse of the Holy Spirit and she knows better than anyone else how to yield to Him. And so, echoing Mary's Magnificat, I want to proclaim that, "God who is mighty has done great things for us, and holy is His name!" AMEN! © Patti Gallagher Mansfield, 2007, www.ccrno.org

SUMMARY. We are excited to announce that the National Service Committee (NSC) of the Catholic Charismatic Renewal has been presented a unique opportunity to purchase the Providence Villa Retreat Center ("Center"), north of Pittsburgh, PA, formerly known as The Ark and The Dove. It was there in February 1967, at what is often referred to as the "Duquesne Weekend," that there was an outpouring of the Holy Spirit along with the charisms for the renewal of the Catholic Church. Since then, millions have experienced the grace of baptism in the Holy Spirit. Recognizing the

outpouring of God's grace, the recent popes have heartily encouraged those in the Renewal to use these charisms to build the Kingdom. Upon purchase of the Center, the former name will be restored, and the facility will be used for Renewal purposes, for retreats, pilgrimages and other events, to foster baptism in the Holy Spirit and use of the charisms. Timing is providential as the Renewal worldwide is preparing for the 50th anniversary of the Duquesne Weekend in 2017.

PURCHASE OF CENTER. Originally offered to the NSC, prayerful discernment led to the conclusion that the Center should not be owned or operated by a single Renewal group, but should be extended to other Renewal service organizations, covenant communities, religious other and individuals. orders, groups, Participation would provide these groups and individuals preferential access before extending Center usage to others. The \$1.3 million price includes the well-maintained retreat house and cottage on 16.5 wooded acres, as well as the existing furniture, fixtures and equipment. The property will be inspected before closing to ensure that deferred maintenance is addressed or the price is adjusted accordingly.

(800) 338-2445 chariscenter@nsc-chariscenter.org www.nsc-chariscenter.org **HISTORY.** Built in 1924 by Bell Telephone as a respite place for their female employees, it was later sold to become a private boarding school. The Center was purchased in 1964 by the Catholic Diocese of Pittsburgh and was operated by the Ladies of Bethany as The Ark and The Dove Retreat Center; the Diocese later renamed it the Cardinal Wright Center and used it for spiritual renewal for clergy and religious. The Center was purchased in 2000 by the Sisters of Divine Providence, who renovated the buildings and currently operate it as Providence Villa.

The sisters now seek to sell the property and use the proceeds to renovate their mother house. Over the years several parties have expressed interest in acquiring the Center, including the NSC, which has led to this purchase opportunity.

PROPOSED STRUCTURE. After preliminary due diligence of possible structures to acquire the Center, it appears the most appropriate structure would be the formation of a new Pennsylvania nonprofit, either as a free-standing entity or an NSC subsidiary, which would be funded by donations from Renewal groups and individuals (for working purposes this entity is called A&D Co., or "A&D"). This structure would be designed to permit international participation without foreign taxes. Assuming this structure, Form 1023 will be filed with the IRS so all donations to A&D from inception will be deductible.

To expedite the purchase, due diligence and organizational process, the NSC intends to submit the proposal to acquire the Center with 120 day exclusivity, while reserving the right to rename the purchasing entity, i.e., A&D.

The A&D Board of Directors would represent participating Renewal organizations and individuals, with selection based on donation amount and other factors. The board will elect the chairman. Alternatively, if there is a decision to proceed with a lease-to-own arrangement, should large corporate or individual purchasers be identified, then the board composition will include representatives selected from different Renewal groups and individuals.

It is anticipated that the Center staffing will be A&D employees, who would be compensated by the revenue generated from Center activities. A detailed business plan is being prepared for the A&D nonprofit structure.

WEBINAR. To learn more about how to support the purchase of the Center, the NSC will host webinars in September 2015. A second webinar (in English) may be held to accommodate the schedules of interested international parties. Details of the webinars will be forthcoming shortly.









Providence Villa Facilities

The three-story Providence Villa (the main house) has 13 bedrooms, several meeting rooms, a kitchen, library, and formal dining room, and can accommodate retreats and meetings for up to 20 people.

There is a small nearby cottage, Fern Hill, which has a kitchen and rooms that accommodate six beds.

Other amenities include food service, audio-visual equipment, wireless internet, conference calling, woodburning fireplaces, a chapel, screened gazebo, and beautiful grounds.





Basis for Preparation of Business Plan

The NSC has entered into the agreement to purchase the property and developed this benefit plan to fulfill the vision of unifying the various expressions of the Renewal and to establish a location of identity for the Renewal worldwide, especially given the importance of The Ark and The Dove in the birth of Catholic Charismatic Renewal.



This plan reflects the \$1.3 million purchase of The Ark and The Dove by a new nonprofit formed by various Renewal groups, covenant communities, other organizations and individuals worldwide.

The NSC entered into an agreement August 21, 2015 to purchase Provident Villa from the Sisters of Divine Providence, and paid a \$65,000 earnest money deposit. This agreement provides for a 60 day due diligence period, and, if there are no material issues and there is sufficient fundraising, a second 60 day period will commence and another \$65,000 will be added to the earnest money deposit. Such deposits will be applied to the purchase price.

In the second 60 day period, the NSC will assign the agreement to the new nonprofit for closing the purchase in late December. Funds raised above the purchase price and closing costs will be deposited into a new bank account of the new nonprofit.



Fundraising Campaign

There is a two-pronged fundraising initiative being conducted to fund the purchase – (1) a wholesale strategy in which major partners will participate and (2) a retail strategy in which individuals and groups can participate with smaller donations

The fundraising campaign is focused on raising \$1.5 million by the scheduled closing date in late December 2015, with a majority of such funds raised in cash before the end of the first 60 day due diligence period.

It is anticipated that there will be several major "partners" who will jumpstart the fundraising campaign to attract other major donors, both organizations and individuals.

Once several partners have been identified, they will assist in the fundraising through their organizations and networks, as well as participating in several fundraising events, such as webinars.

The fundraising campaign is global in scope and includes those involved in the Catholic Charismatic Renewal, covenant communities, and other ecumenical groups.



While fundraising will be ongoing after the purchase, retreat and pilgrimage fees are expected to cover the costs.

Pro Forma Business Plan

Once acquired by the NSC, Providence Villa will be renamed The Ark and the Dove.

Providence Villa will be renamed The Ark and The Dove after the NSC purchase.

Retreat operations will resume after the purchase, but use of The Ark and The Dove will expand significantly as a major center for the Catholic Charismatic Renewal, including organizational meetings, planning joint Renewal activities and other services to support the Renewal worldwide.

Another role will be a prime pilgrimage location for the Renewal, especially with the approaching 50th Anniversary of the Duquesne Weekend in 2017 and regular celebrations such as Pentecost Sunday.

The Ark and The Dove not only has considerable historical importance to the Renewal, but it has a unifying feature as well, bringing together the various groups with the CCR movement worldwide for the purpose of inspiring those in the Renewal to foster the charisms for the building up of the Church today.




Four-Fold Usage of The Ark & The Dove:




Four-Fold Usage of The Ark & The Dove:

Objective




Four-Fold Usage of The Ark & The Dove: **Praise & Worship Events**

Outdoor tents may be used for larger groups.






Four-Fold Usage of The Ark & The Dove: Symbol of Unit of the Catholic Charismatic Renewal

Objective

Although it is important that the CCR remain open to the movement of the Holy Spirit, by having one location for leaders to assemble to pray together, witness to what is working and to more effectively evangelize and carry out the mission to increase those in the Church who have been baptized in the Holy Spirit and increase the utilization of the charisms in the Church, the Retreat Center provides a central place of seeking to work with greater unity.





Operational Considerations

The initial pro forma financial projections are assumed to commence in January 2016.

The assumed staffing and other operational costs for the Retreat Center are based current Providence Villa operations (to the extent they are known on a pre-due diligence basis) and the historical costs at other retreat centers based on publicly available Form 990s as well as Living Water Retreat Center information provided by NSC member Bill Marcotte who was the Executive Director and Lumen Christi Retreat Center by NSC member Bishop Sam Jacobs.

The analysis assumes a \$1.3 million purchase price, standard closing costs, a 25% down-payment and bank financing with a 25 year amortizing loan with an interest rate of 5%. A greater down-payment will increase the profitability of the operations.

The pro forma financial projections do not reflect the headquarters relocation and assume a partial vacancy throughout the year.


Staffing Assumptions

- 2. **Formation of New Nonprofit.** Assuming sufficient funds have been raised by October 20, 2015, the NSC will take steps to form a new nonprofit, a 501(c)(3) corporation designated by the Internal Revenue Service.
